

# Human Complement Factor H / CFH ELISA Pair Set

## Catalog Number : SEK10714

To achieve the best assay results, this manual must be read carefully before using this product and the assay is run as summarized in the General ELISA protocol.

#### BACKGROUND

Complement factor H, also known as H factor 1, and CFH, is a sialic acid containing glycoprotein that plays an integral role in the regulation of the complement-mediated immune system that is involved in microbial defense, immune complex processing, and programmed cell death. Factor H protects host cells from injury resulting from unrestrained complement activation. CFH regulates complement activation on self cells by possessing both cofactor activity for the Factor I mediated C3b cleavage, and decay accelerating activity against the alternative pathway C3 convertase, C3bBb. CFH protects self cells from complement activation but not bacteria/viruses. Due to the central role that CFH plays in the regulation of complement, there are many clinical implications arrising from aberrant CFH activity. Mutations in the Factor H gene are associated with severe and diverse diseases including the rare renal disorders hemolytic uremic syndrome (HUS) and membranoproliferative glomerulonephritis (MPGN) also termed dense deposit disease (DDD), membranoproliferative glomuleronephritis type II or dense deposit disease, as well as the more frequent retinal disease age related macular degeneration (AMD). In addition to its complement regulatory activities, factor H has multiple physiological activities and 1) acts as an extracellular matrix component, 2) binds to cellular receptors of the integrin type, and 3) interacts with a wide selection of ligands, such as the C-reactive protein, thrombospondin, bone sialoprotein, osteopontin, and heparin.

## PRINCIPLE OF THE TEST


The Sino Biological ELISA Pair Set is a solid phase sandwich ELISA (Enzyme-Linked Immunosorbent Assay). It utilizes a monoclonal antibody specific for Human Complement Factor H / CFH coated on a 96well plate. Standards and samples are added to the wells, and any Human Complement Factor H / CFH present binds to the immobilized antibody. The wells are washed and a horseradish peroxidase conjugated mouse anti-Human Complement Factor H / CFH monoclonal antibody is then added, producing an antibody-antigen-antibody "sandwich". The wells are again washed and TMB substrate solution is loaded, which produces color in proportion to the amount of Human Complement Factor H / CFH present in the sample. To end the enzyme reaction, the stop solution is added and absorbances of the microwell are read at 450 nm.

#### **INTENDED USE**

◆The Human Complement Factor H / CFH ELISA Pair Set is for the quantitative determination of Human Complement Factor H / CFH.

•This ELISA Pair Set contains the basic components required for the development of sandwich ELISAs.

#### ASSAY PROCEDURE SUMMARY



This Pair Set has been configured for research use only and is not to be used in diagnostic procedures.

## MATERIALS PROVIDED

#### Bring all reagents to room temperature before use.

**Capture Antibody** – 0.5 mg/mL of mouse anti-Human Complement Factor H / CFH monoclonal antibody (in PBS, pH 7.4). Dilute to a working concentration of 2 µg/mL in PBS before coating. (Catalog: # 10714-MM02)

**Detection Antibody** – 0.2 mg/mL of mouse anti-Human Complement Factor H / CFH monoclonal antibody conjugated to horseradish-peroxidase (HRP) (in PBS, 50 % HRP-Protector, pH 7.4, store at  $4^{\circ}$ C). Dilute to working concentration of 0.5 µg/mL in detection antibody dilution buffer before use. (Catalog: # 10714-MM03)

**Standard** – Each vial contains 38 ng of recombinant Human Complement Factor H / CFH. Reconstitute with 1 mL detection antibody dilution buffer. After reconstitution, store at -20 $^{\circ}$ C to - 80 $^{\circ}$ C immediately (in 15 mins) in a manual defrost freezer, otherwise the value could decrease significantly. A seven-point standard curve using 2-fold serial dilutions in sample dilution buffer, and a high standard of 3000 pg/mL is recommended.

## SOLUTIONS REQUIRED

**PBS** - 136.9 mM NaCl, 10.1 mM Na<sub>2</sub>HPO<sub>4</sub>, 2.7 mM KCl, 1.8 mM KH<sub>2</sub>PO<sub>4</sub>, pH 7.4, 0.2 μm

filtered

**TBS** - 20 mM Tris, 150 mM NaCl, pH 7.4

Wash Buffer - 0.05% Tween20 in TBS, pH 7.2 - 7.4

Blocking Buffer - 2% BSA in Wash Buffer

Sample dilution buffer - 0.1% BSA in wash buffer, pH 7.2 - 7.4, 0.2 µm filtered

Detection antibody dilution buffer - 0.5% BSA in wash buffer, pH 7.2 - 7.4, 0.2 µm filtered

Substrate Solution : To achieve best assay results, fresh substrate solution is recommended

Substrate stock solution - 10mg / ml TMB (Tetramethylbenzidine) in DMSO

Substrate dilution buffer - 0.05M  $Na_2HPO_4$  and 0.025M citric acid; adjust pH to 5.5

Substrate working solution - For each plate dilute 250 µl substrate stock solution in 25ml

substrate dilution buffer and then add 80  $\mu I~$  0.75%  $H_2O_2$  , mix it well

Stop Solution - 2 N H<sub>2</sub>SO<sub>4</sub>

## PRECAUTION

The Stop Solution suggested for use with this Pair Set is an acid solution. Wear eye, hand, face, and clothing protection when using this material.

## STORAGE

**Capture Antibody**: Aliquot and store at -20 $^{\circ}$ C to -80 $^{\circ}$ C for up to 6 months from date of receipt. Avoid repeated freeze-thaw cycles.

**Detection Antibody**: Store at  $4^{\circ}$ C and protect it from prolonged exposure to light for up to 6 months from date of receipt. **DO NOT FREEZE!** 

**Standard**: Store lyophilized standard at -20°C to -80°C for up to 6 months from date of receipt.

Aliquot and store the reconstituted standard immediately (in 15 mins) in a manual defrost freezer, otherwise the value could decrease significantly. The reconstituted standard can be stable for up to 1 month at -80 °C. Avoid repeated freeze-thaw cycles.

## **GENERAL ELISA PROTOCOL**

#### **Plate Preparation**

1.Dilute the capture antibody to the working concentration in PBS. Immediately coat a 96-well microplate with 100 $\mu$ L per well of the diluted capture antibody. Seal the plate and incubate overnight at 4°C.

2.Aspirate each well and wash with at least 300µl wash buffer, repeating the process two times for a total of three washes. Complete removal of liquid at each step is essential for good performance. After the last wash, remove any remaining wash buffer by inverting the plate and blotting it against clean paper towels. 3.Block plates by adding 300  $\mu$ L of blocking buffer to each well. Incubate at room temperature for a minimum of 1 hour.

4.Repeat the aspiration/wash as in step 2. The plates are now ready for sample addition.

#### Assay Procedure

1.Add 100  $\mu$ L of sample or standards in sample dilution buffer per well. Seal the plate and incubate 2 hours at room temperature.

2.Repeat the aspiration/wash as in step 2 of plate preparation.

3.Add 100 µL of the detection antibody, diluted in antibody dilution buffer, to each well. Seal the plate and incubate 1 hour at room temperature.

4.Repeat the aspiration/wash as in step 2 of plate preparation.

5.Add 200  $\mu$ L of substrate solution to each well. Incubate for 20 minutes at room temperature ( **if substrate solution is not as requested, the incubation time should be optimized** ). Avoid placing the plate in direct light.

6.Add 50  $\mu$ L of stop solution to each well. Gently tap the plate to ensure thorough mixing.

7. Determine the optical density of each well immediately, using a microplate reader set to 450 nm.

## **CALCULATION OF RESULTS**

•Calculate the mean absorbance for each set of duplicate standards, controls and samples. Subtract the mean zero standard absorbance from each.


•Construct a standard curve by plotting the mean absorbance for each standard on the y-axis against the concentration on the x-axis and draw a best fit curve through the points on the graph.

•To determine the concentration of the unknowns, find the unknowns' mean absorbance value on the yaxis and draw a horizontal line to the standard curve. At the point of intersection, draw a vertical line to the x-axis and read the concentration. If samples have been diluted, the concentration read from the standard curve must be multiplied by the dilution factor.

•Alternatively, computer-based curve-fitting statistical software may also be employed to calculate the concentration of the sample.

### **TYPICAL DATA**

This standard curve is only for demonstration purposes. A standard curve should be generated for each assay.

#### PERFORMANCE CHARACTERISTIC

#### SENSITIVITY

The minimum detectable dose of Human Complement Factor H / CFH was determined to be approximately **46.88 pg/ml**. This is defined as at least three times standard deviations above the mean optical density of 10 replicates of the zero standard.

	Imprecise / inaccurate pipetting	Check / calibrate pipettes			
	Incubations done at inappropriate temperature, timing or agitation	Follow the general ELISA protocol			
	Background wells were contaminated	Avoid cross contamination by using the sealer appropriately			
	The concentration of antigen in samples was too low	Enriching samples to increase the concentration of antigen			
Poor detection value	Samples were ineffective	Check if the samples are stored at cold environment. Detect samples in timely manner			
High Background	Insufficient washes	Use multichannel pipettes without touching the reagents on the plate			
	insuncient wasnes	Increase cycles of washes and soaking time between washes			
	TMB Substrate Solution was contaminated	TMB Substrate Solution should be clear and colorless prior to addition to wells
